Medical Doctors have become more and more bound by rules and regulations designed to increase big pharma profit.

This makes patients sick and doctors depressed

Conventional Medicine, a religion and not a science?



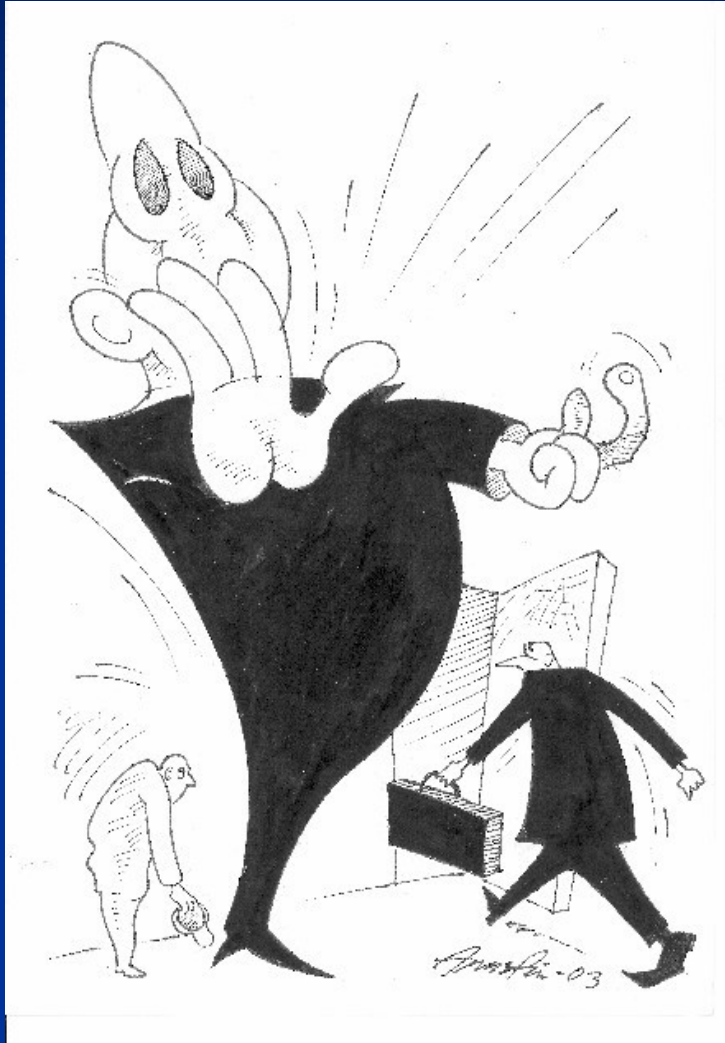
Many medical diagnostic criterias were invented > 100 years ago

>A large number of patients do not fit in the system

"Misfit" patients get neglected

Doctors only look in one direction and fails to record symptoms and signs that do not confirm their world-view.

What happens if you discover a cheap cure for Cancer?



- If the cure is Patentable, it will not be cheap.
- If the cure is not Patentable = No money for research and limited access to university clinics.
- If anyway you manage to make a study, there will be problems to get it published in the major medical papers.
- It would most probably be actively combated by the FDA and other health authorities, who are all dependant on Big Pharma

Many patients know they cannot trust their conventional doctors and look for alternative cures on the internet

Many alternative therapists promise too much for too much money

It is hard for the patients to evaluate who they can trust

Who can pay?



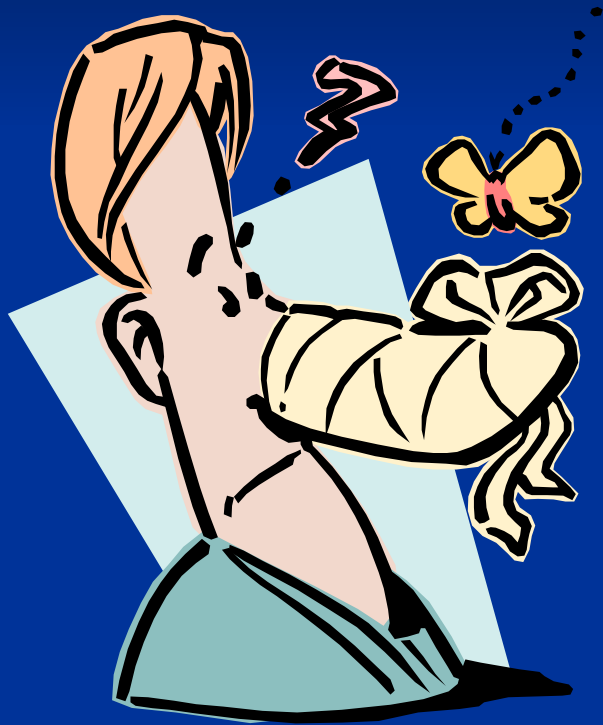
Conventional medicines become more and more expensive, a new cancer treatment can cost > US\$ 100 000/year

Most of the worlds cancer patients cannot pay for the new medicines

In developing countries many citizens can also not afford to go to a doctor.

Modern medicine is becoming reserved only for the rich and and wealthy

How Can We Solve the Problem?



An Independent Medical Information Portal.

A Medical Record System that automatically will propose the best treatments and evaluate all treated patients

A new kind of medical profession – Independent Healers, who will be in charge of this information system.

A largely web -based education for these "Independent Healers"

Solution 1

An unbiased Medical Information Portal



- A multi-layered website with info for both patients, professionals and researchers
- All contributions/research reports/case reports will be evaluated, debated and rated by the participants.
- All interesting new discoveries will be immediately made available to the public, without bias from propaganda and advertisements.

Solution 2

A new kind of Medical Record System

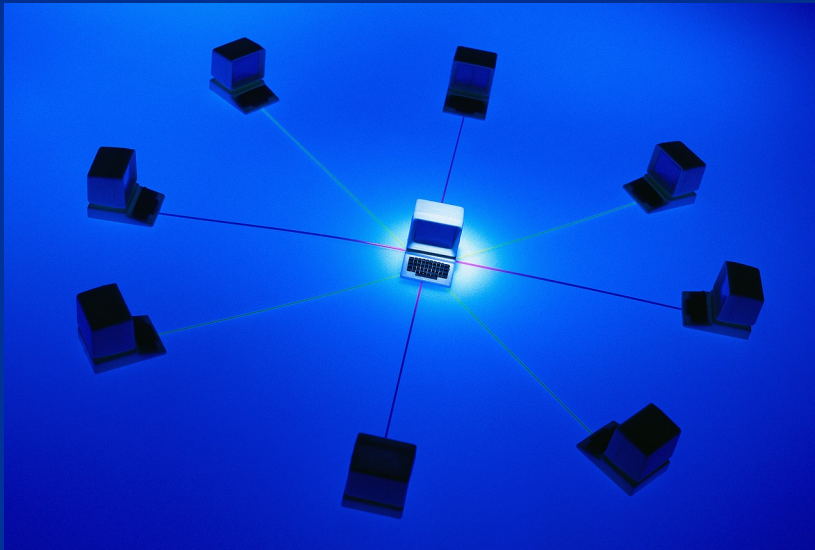
Automatic Recording of signs and symptoms with web questionnaires

Automatic suggestion of the best possible treatments evaluated by the medical information portal

Symptoms and Signs will be in Focus, not Diagnosis.

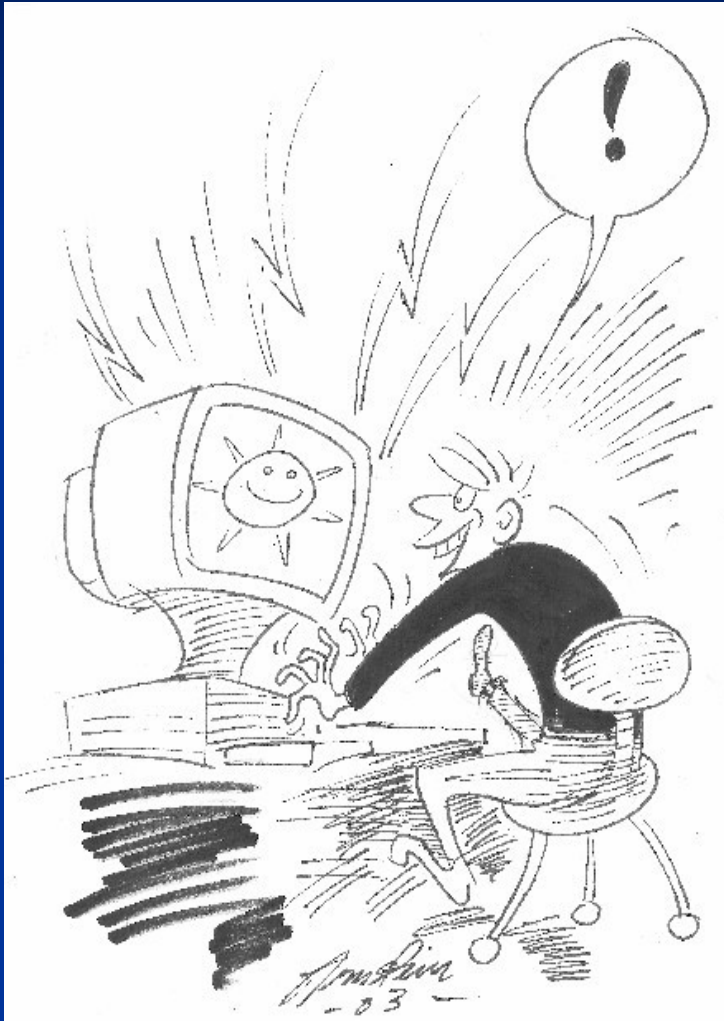
Automatic follow up of all recorded treatments.

Solution 3

Independent Healers



A new kind of medical professionals who will be involved in inviting patients to interact with the biggest medical information system on the planet

Can also make referrals to ie surgeons and radiologists

Medical Doctors and other conventional health professionals are also welcome to become independent healers

The Independent Healer Education

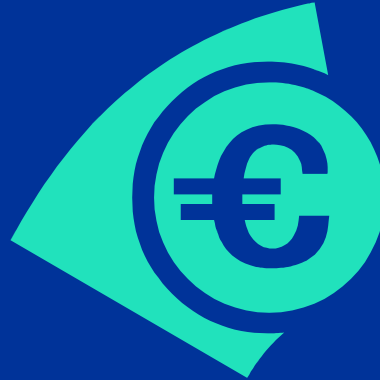


A Web based education based on the "Plugghäst" concept

Can be easily accessible on smartphones, surf pads and cheap computers in the developing countries.

Sources of Income



- Fee for each patient, ie 10% of the total consultation fee.
- Gradation fees.
- Project funding to be obtained from patient organizations, philanthropists, governments, the European Union and WHO.
